On December 12, 2022 (December 13, 2022 (JST)), Meiji Seika Pharma Co., Ltd. ("<u>Meiji</u>") announced it has started a Phase III clinical trial in Japan of ARCT-154, Arcturus Therapeutics Holdings Inc.'s (the "<u>Company</u>" or "<u>Arcturus</u>") self-amplifying mRNA vaccine candidate against COVID-19. The trial is targeted to include a total of 780 adult participants, with half in the ARCT-154 group and half in a comparator group, and to evaluate non-inferiority of ARCT-154 as a booster series.

On December 12, 2022, CSL Seqirus ("<u>CSL</u>") published a press release announcing that the previously announced collaboration agreement dated November 1, 2022 between the Company and CSL, became effective on December 8, 2022.
